ESSENTIAL FUNCTIONS: This is professional level work in which the individual reviews, analyzes, and makes recommendations concerning requests for coastal wetlands permits submitted to the Office of Coastal Resource Management at the Mississippi Department of Marine Resources. Inspection of permit violations is also required. Travel is required to make site inspections of proposed permit activities within the three coastal counties of Mississippi.

KNOWLEDGE, SKILLS, AND ABILITIES: The ideal candidate should have a working knowledge of coastal and estuarine ecosystems of the Gulf of Mexico, coastal resource management techniques, the fauna and flora of the Gulf of Mexico, and ecological principles. Knowledge of wetlands delineation is desired. Candidates also need to possess excellent verbal and written communication skills; be able to appropriately interact with a wide variety of people; possess skill in executing multiple projects simultaneously; have excellent negotiation, computer,

and presentation skills; and, have the ability to exercise considerable judgment and discretion. Degrees in biology, botany, geography, ecology, environmental science, forestry, or wildlife biology are preferred.

EDUCATION & EXPERIENCE REQUIREMENTS: A Bachelor's Degree from an accredited four-year college or university in biology, botany, geology, geography, ecology, anthropology, archaeology, environmental science, forestry, wildlife biology, or a related field.
