Actions Update

June 15, 2021

Discussed at the May 2021 meeting:

- 1) Motion to recommend that the 2021-2022 shrimp season be opened by the Director when sampling shows Brown Shrimp have reached the average of 68 count per pound.
- Commission recommended approval of the request.
- Director approved the request.

Pending Items for Discussion

- 1) Commission's motion to recommend a Violation and fine in the amount of \$5000.00 to Shawn Gollott for the unauthorized placement of rip-rap and for an After-the-Fact general permit for the existing rip-rap and construction of piers as proposed in the Back Bay of Biloxi, 3393 and 3387 Bay Shore Drive in D'Iberville, Harrison County, MS.
- 2) Commission's motion to recommend that the request for after-the-fact authorization for existing boathouse, approval for proposed boathouse, and recommended fine for violation to the contractor, Cleo Benward, be tabled until such time that more information can be obtained from Vivek Barclay, the owner of the property located on Bayou Porteaux, 14113 El Camino Real Road in Ocean Springs, Jackson County, MS.

Changes to Title 22

Changes to Title 22 Part 22

- Reflects changes prescribed by HB 827.
- Removed wording that was already covered in Mississippi Code but includes references to the applicable statutory or regulatory authorities.
- Updated the format to “Rules” and “Sources” to conform with the format prescribed by the Secretary of State’s Office.

Substantive Changes

- Changed the Commission's authority to advisory to the Executive Director.
- Added provision for educational meetings where no commission action is necessary.
- Deleted the four (4) hours advance notice of Called Special Meetings – conflicts with MS statute. MS statute will be followed.
- Changed to reflect that the Executive Director establishes the agenda for the public meetings.
- Clarified that public comments related to an agenda item will be taken up during discussion of that item and all other public comments will be heard during the Public Comments section of the meeting.

- Established the three (3) minute time frame for each individual to make public comments.
- Revised the Regulations section to reflect Commission's advisory role.
- Removed the Petitions for Review section – that information is covered in Title 22, Part 15, which will also be revised based upon HB 1211.
- Deleted the Policies and Directives section based upon the changes to the Commission's role as advisory.
- Deleted the Changes to Commission Handbook section – changes will be processed as all other regulation changes.

Notice of Intent

Recommendation to the Executive Director that the new format and changes to Title 22, Part 22 be sent to the Secretary of State's Office for Notice of Intent.
