
Re: Tidelands Proposals

The Mississippi Department of Marine Resources (MDMR) is currently requesting proposals for Fiscal Year 2024 Tidelands Trust Funds. You may find an electronic version of the application on the MDMR website at www.dmr.state.ms.us. Those seeking to qualify for Tidelands Funds for Fiscal Year 2024 must submit a proposal to the Department of Marine Resources (DMR) for consideration. Requests for funding should be submitted online through the MDMR website or may be received at the MDMR office located at 1141 Bayview Avenue, Biloxi, Mississippi until 5:00 p.m. on Friday, July 1, 2022. Submitted proposals will be reviewed and prioritized according to established criteria. The Department of Marine Resources will then forward proposals to the Mississippi Legislature when it reconvenes in January 2023.

Applicants are reminded of the legislative intent of the Public Trust Tidelands Funds for “new and extra programs of tidelands management, such as conservation, reclamation, preservation, acquisition, education or the enhancement of public access to tidelands or public improvement projects as they relate to those lands.”
