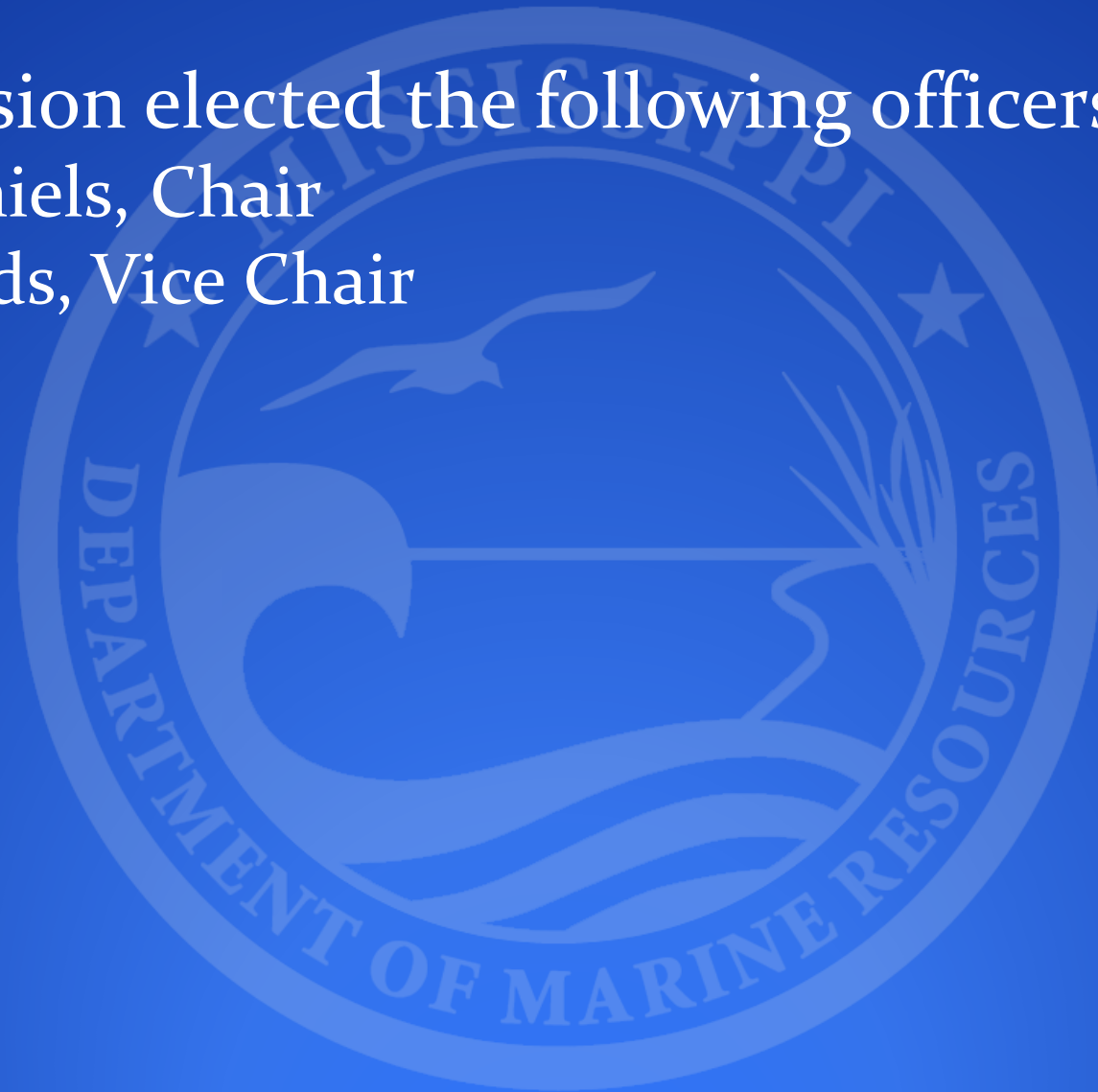

Actions Update for August 20, 2022 Commission Meeting

Discussed at the July 2022 meeting:

- The Commission recommended and the Director approved the following motions:
 - 1) No Wake Zone for Old Fort Bayou Waterway:
 - (i) From Northern coordinates $30^{\circ}25'07.68''$ N, $88^{\circ}50'03.30''$ W approximately 980 feet to Southern coordinates $30^{\circ}24'58.98''$ N, $88^{\circ}50'05.92''$ W. – Approve
 - (ii) From Northern coordinates $30^{\circ}25'04.63''$ N, $88^{\circ}50'02.75''$ W approximately 660 feet to Southern coordinates $30^{\circ}25'00.06''$ N, $88^{\circ}50'04.41''$ W. – Approve
 - (iii) From Western coordinates $30^{\circ}25'08.58''$ N, $88^{\circ}49'52.86''$ W approximately 1,610 feet to Eastern coordinates $30^{\circ}25'11.94''$ N, $88^{\circ}49'35.14''$ W. – Table for future consideration.

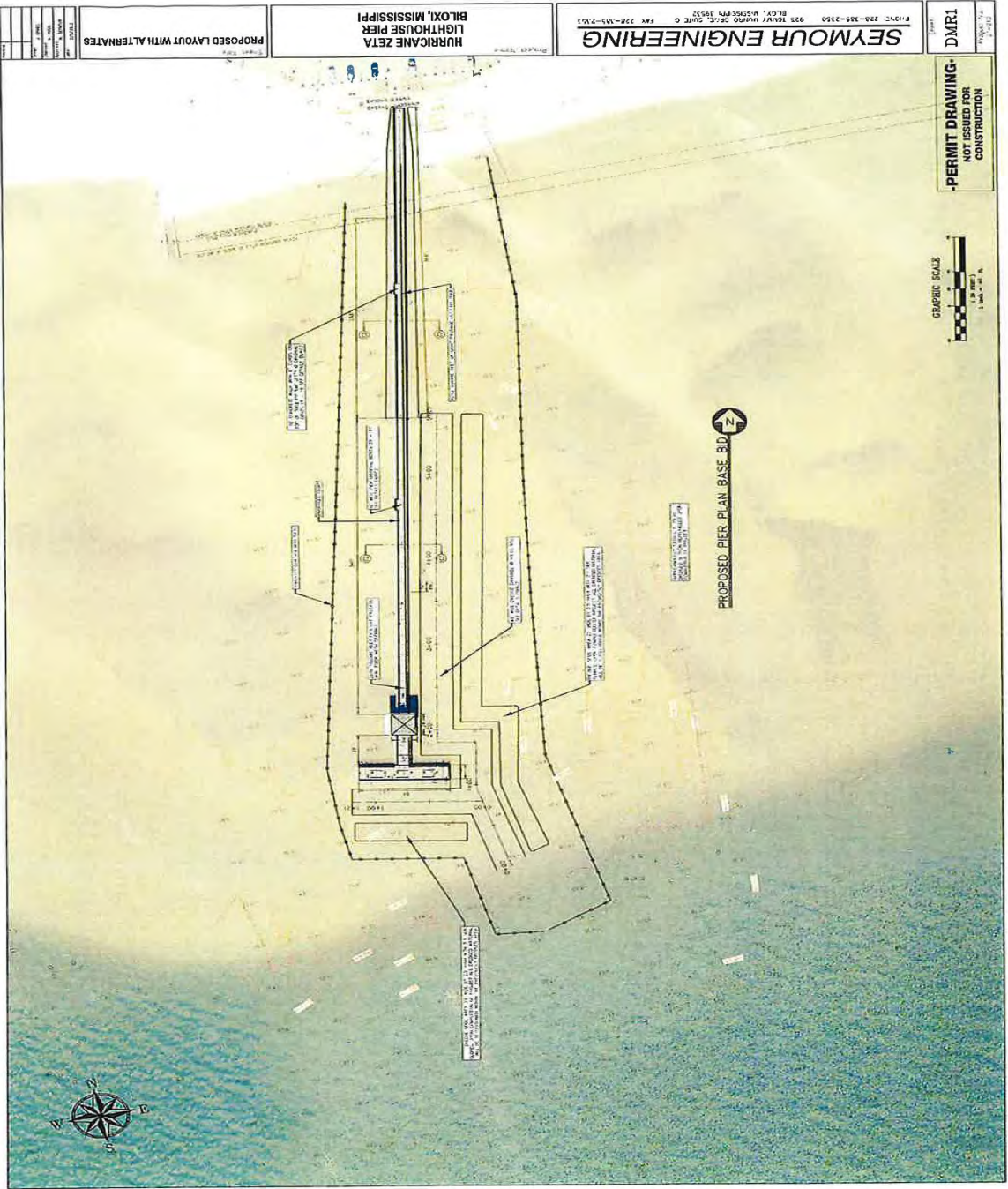
- **Location: Mississippi Sound at the Intersection of U.S. Highway 90 and Porter Avenue, Biloxi, Harrison County, MS.**
- **Use District: (G) General Use District**
- **Agent: Seymour Engineering**

Project Description

- **Fill/Jetty:**
 - Sand Beach: 120' X 23' = 2,760 sf
 - Unvegetated waterbottoms: 240' X 23' = 5,520 sf
- **Structures:**
 - Pier: 345' X 8' w/ bench seating area: 12' X 2'
 - Covered Pier: 24' X 24'
 - Pier: 35' x 12'
 - Pier: 84' X 16'
- **Dredging (Temporary work channel):**
 - 670' X 40'
- **Proposed depth: 4' below MLW**

The applicant has requested a variance to Miss. Admin. Code Title 22, Part 23, Chapter 8, Section 114.01 which states, "Permanent filling of coastal wetlands below the mean high tide line because of potential adverse and cumulative environmental impacts is not authorized,"

Justification: Miss. Admin. Code Title 22, Part 23, Chapter 8, Section 118.04 by stating the activity requires a waterfront location; there is a significant public benefit in the activity; and a public hearing was held.







Public and Agency Notification

 - No public comments were/have been received
 - A public hearing will be held on Tuesday, August 9, 2022 at 5:30 p.m. at the Bolton Building Auditorium located at 1141 Bayview Avenue, Biloxi, MS.
 - MS DEQ: Currently reviewing the project
 - MS DAH: No objections
 - MS DWFP: No comments
 - MS SOS: Area is already under and existing PTT lease

Recommendation

- The staff of the Department of Marine Resources has conducted a thorough evaluation of the projects and has made findings on the decision factors in accordance with the Mississippi Coastal Program (MCP). Based on the results of these findings, it has been determined that the project is consistent with the MCP because the project serves a higher public purpose by providing more resilient and improved access to the water and provide recreational opportunities to the public. The jetty will also provide attachment sites to provide secondary productivity and provide refuge for numerous marine organisms.
- Staff requests a motion that the Commission recommend to the Executive Director:
 - Approval of the Requested Variance
 - Approval of the Requested Permit contingent on clearance from MDEQ

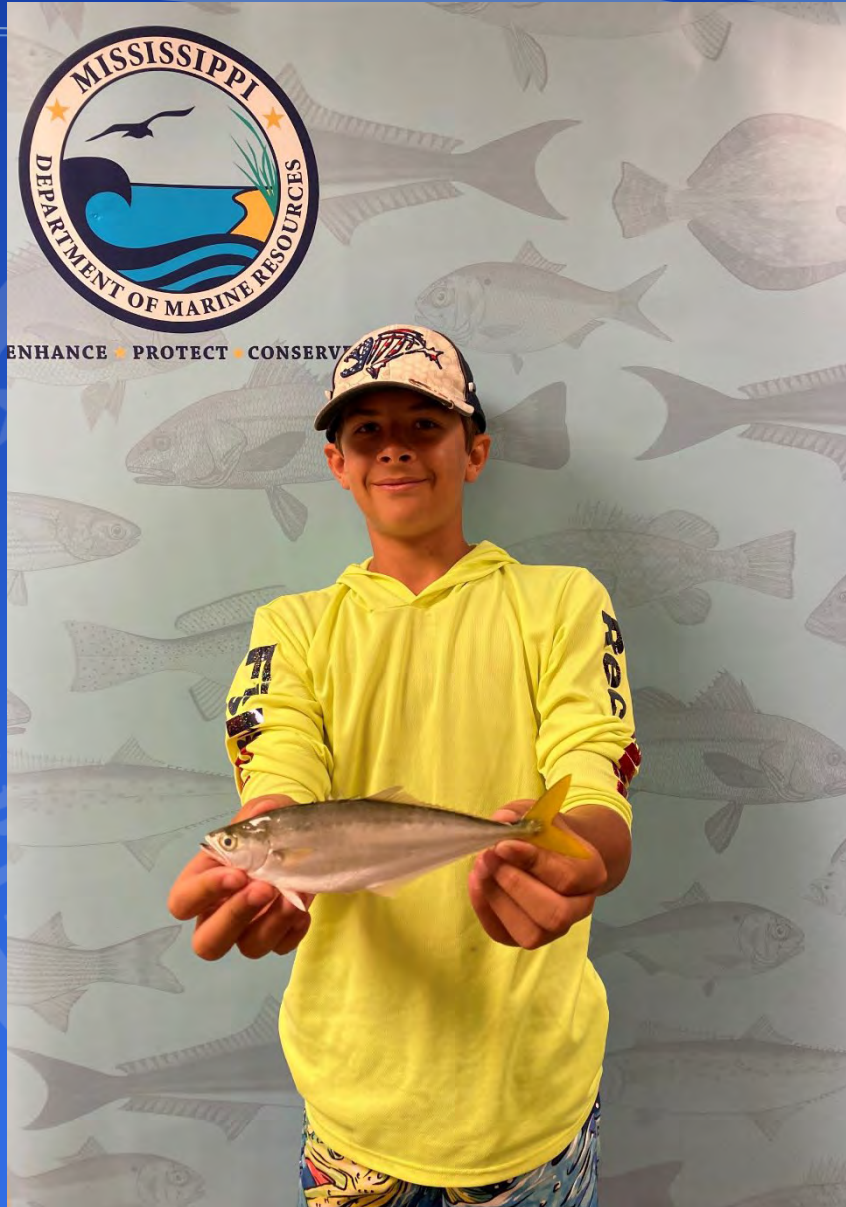
