#### 1. INTRODUCTION

The Mississippi Department of Marine Resources (MDMR) manages the coastal resources for the State of Mississippi. We are dedicated to enhancing, protecting and conserving the marine interests of Mississippi for present and future generations. We manage all marine life, public trust wetlands, adjacent uplands and waterfront areas for the long-term recreational, educational, commercial, and economic benefit of everyone.

#### 2. PURPOSE

The MDMR is seeking bids from individuals or companies for items for auction at the MDMR Lyman Fish Hatchery. All items will be offered by lot. This will be a sealed bid auction with each lot of item or items being awarded to the highest bid received.

#### **SITE VISIT:**

The MDMR will have a Site Visit on Tuesday, May 14; and Wednesday, May 15, 2024 from 9:00 a.m. to 3:00 p.m. to allow potential bidders an opportunity to view and inspect the items for bid, present questions to staff, and to obtain clarification of the bidding requirements. Site visit is located at the Lyman Fish Hatchery, 16193 Fish Hatchery Rd., Gulfport, MS 39503.

#### 3. SCOPE OF AUCTION

The Scope for the Lyman Auction will include, but is not limited to, the following:

- 1. All items available for bid are located at the Lyman Fish Hatchery, 16193 Fish Hatchery Rd., Gulfport, MS 39503.
- 2. All items for bid, including Lot number, description, and minimum bid are attached. (Attachment A).
- 3. All items are sold **AS IS**, without any warranty. MDMR disclaims any and all warranties, express or implied, as to the items to be sold.
- 4. Once a bid is submitted to the MDMR, it cannot be withdrawn.
- 5. Payment for winning bids will be in the form of a certified check or money order and due within two (2) days of notification of winning bid. Payments not made within two (2) days will result in forfeiture of bid.

- 6. Items must be picked up between May 27, 2024 and June 6, 2024.
- 7. If items are not picked up within the above stated timeframe the item will be awarded to the next highest bidder.

### 4. BASIS FOR AWARD

The MDMR will award each lot to the highest bidder for that lot number. In the event of nonpayment or the lot not being picked up as stated in Section 3, Scope of Auction, the lot will be awarded to the next highest bidder.

### **BID SUBMISSION INSTRUCTIONS**

### **Bid Submission Requirements**

- The bid submission must be signed and submitted in a sealed envelope. It must be submitted to MDMR Procurement Department, 6<sup>th</sup> Floor, at 1141 Bayview Avenue, Biloxi MS 39530 no later than 2:00 PM CST, May 22, 2024.
- Timely submission is the responsibility of the bidder. Submissions received after the specified time will be rejected and the unopened bid will be made a part of the procurement file.
- The time and date of receipt will be indicated on the envelope or package by the MDMR staff.
- All prices and notations must be printed in ink or typewritten. No erasures permitted. Errors may be crossed out and corrections printed in ink or typewritten adjacent and must be initialed, in ink, by the person signing bid.
- It is suggested that if a submission is mailed to MDMR, it should be posted in certified mail with a return receipt requested. MDMR will not be responsible for mail delays or lost mail.
- Bids submitted by hand delivery or mail will become the property of the MDMR.
- Bids should be mailed, or hand delivered and must be labeled as follows:

### 5. AMENDMENTS TO THIS IFB

Should an amendment or amendments to this IFB be issued by MDMR, it will be posted on the MDMR website <a href="mailto:dmr.ms.gov">dmr.ms.gov</a> and on the Mississippi Contract Procurement Opportunity Search Board (Procurement Portal) website <a href="mailto:ms.gov/dfa/contract\_bid\_search/Bid">ms.gov/dfa/contract\_bid\_search/Bid</a> in a manner that all bidders will be able to view. Furthermore, bidders must acknowledge receipt of any amendment to this IFB by signing and returning the amendment with the bid submission, or by identifying the amendment number and date in the space provided for this purpose on the Bid Form-Attachment C, or by letter. The acknowledgment must be received by the MDMR by the time and at the place specified for receipt of Bids. It is the bidder's sole responsibility to monitor the website for amendments to the IFB.

All bids must include the following:

Use the bid form to identify your best price. You must identify your name on each page of the bid form, and each of the attachments. Complete all of the blanks and sign the form.

You *must* use the bid form. Submissions without a bid form will be rejected as nonresponsive. Do not amend or add to the bid form. We may reject modified bid forms as nonresponsive on a case-by-case basis.

You are responsible for the costs of preparing your bid. We do not accept liability for such expenses.

#### 8. CONDITIONS OF SOLICITATION

When you submit a bid, then you promise that you will accept, pay for, and pick up (from the Lyman Fish Hatchery) any item awarded to you. You also certify that you have not communicated with any other bidder or competitor regarding your bid or the price, your intention to submit a bid, or the factors you used to calculate the bid price.

The MDMR reserves the right to reject any and/or all bids and waive any minor informality.

#### 9. NOTIFICATION OF INTENT TO AWARD

Notification will be sent to all bidders by email of the selection of the successful bidder for each lot.

#### 10. GOVERNING LAW

This solicitation and any resulting sale shall be governed in all respects by the laws of the State of Mississippi, excluding its conflict of laws provisions, and any litigation with respect thereto shall be brought in the courts of Biloxi, Harrison County, Mississippi.

MDMR will select the successful bidder(s) without regard to political affiliation, race, color, handicap, genetic information, religion, national origin, sex, religious creed, age, or disability.
